This does not waive the rights of suit in the event that an action is termed criminal within the jurisdiction of applicable law.
2. Agree to indemnify and hold harmless *Midwest 305's*, its officials, and members for any loss, liability, damage, or cost which may incur due to my presence at a *Midwest 305's* event, whether I am competing, officiating, or observing a *Midwest 305's* event.
3. Assure the risks inherent in automobile racing and assume responsibility for the bodily injury or property damage which those risk can cause.
4. Reserve to *Midwest 305's* and its members and official, any rights to publish, produce, copyright, duplicate, reproduce upon hats, tee-shirts, and other such novelty concession items, written articles about me, photos and drawings of my likeness of my racecar. This does not prohibit me from producing promotional products, nor does this allow *Midwest 305's* to take proceeds from materials produced by me, unless marketed by *Midwest 305's*.
5. By signing below, agree to follow all the rules and regulations and responsibilities as printed in the 2010 *Midwest 305's* rules. I hereby release the officials of *Midwest 305's* from damages resulting from their decisions and/or interpretations of the rules.
